Participation in high school extra-curricular activities is a unique privilege for all students, citizen and international. TAPPS' mission remains to provide extra-curricular opportunities for the students of our member schools.

International Students pursue part or all of their high school education at high schools throughout the United States. In addition to the curricular opportunities, many International Students express a desire to enjoy the benefits of participating in extra-curricular activities as well during their high school years. Host schools see benefit in students being active in their school community through participation in athletic and fine art competition.

The National Federation of State High School Associations (NFHS) provides leadership for the state high school associations of all 50 states and affiliate organizations. As an affiliate organization, TAPPS supports the NFHS regulation of International Student participation. While most other NFHS organizations allow participation by only Foreign Exchange Students, TAPPS expands that opportunity by allowing students in the United States for longer periods of time to seek eligibility for participation in TAPPS sponsored extra-curricular activities.

All students must meet eligibility standards established by TAPPS and the member schools. However, for the International Student, participation is not automatic. International Students must be approved in advance of participation by the Foreign Student Committee as established by TAPPS. While many of the TAPPS member schools are registered with SEVIS to accept International Students, not all schools accept international students. Through the approval process, TAPPS seeks to provide a level field of play for all competitions; for the citizen and international student alike.

The rules governing student eligibility are found in the TAPPS Constitution and By-Laws. The rules governing International Student participation in TAPPS are expressed in Section 102 of the TAPPS By-Laws. The Foreign Student Application requires not only completion by the family, but also documentation to assist the Foreign Student Committee in determining and establishing a student's eligibility to compete in TAPPS.

For TAPPS Eligibility purposes, International Students are classified into two groups as outlined below. If a student is not a United States CITIZEN, the *Foreign Student Application* must be submitted and approved by TAPPS prior to student participation in TAPPS extra-curricular activities.
